National Membership Categories

Professional Membership - \$115

Professional members must hold a master's degree or higher in counseling or the substantial equivalent and must be credentialed as a school counselor by a state, district or territory of the United States or the credentialing agency of the country in which they practice or must be employed as counselor educators in a graduate program that prepares school counselors.

Retired Membership - \$60

Members who are in retirement and do not hold full-time positions in school counseling are eligible for retired membership. Retired members hold a master's degree or higher in counseling or the substantial equivalent; are or were credentialed as a school counselor by a state, district or territory of the United States or the credentialing agency of the country in which they practice; or were employed as school counselors, supervisors of school counselors or counselor educators in a graduate program that prepares school counselors.

Student Membership - \$60

Students who are enrolled in a master's program that prepares school counselors and who do not hold full-time positions in school counseling are eligible for student membership.

Affiliate Membership - \$115

Individuals interested in counseling, who are not eligible for any other type of membership, may become affiliate members.
