ASCA Announces 2022 School Counselor of the Year Finalists

ALEXANDRIA, VA – The American School Counselor Association (ASCA) is pleased to announce the five finalists for the 2022 School Counselor of the Year awards program (#SCOY22). The award honors exemplary school counseling professionals who devote their careers to serving as advocates for the nation’s students, helping them achieve success in school and in life. ASCA will announce the 2022 School Counselor of the Year in late fall.

Nominations for the School Counselor of the Year awards program were submitted by ASCA-affiliated state school counselor associations. The School Counselor of the Year awards panel included representatives from AASA: The School Superintendents Association, Advance CTE, Character.org, the Gates Foundation, the National Association for College Admission Counseling, Reach Higher and Strategic Questions Consulting. The awards panel also included representatives from Cape Girardeau Public Schools, Cape Girardeau, Mo.; Escuela Key Elementary, Arlington, Va.; Falls Church City Public Schools, Falls Church, Va.; Hayfield Secondary School, Alexandria, Va.; and St. Theresa School, Ashburn, Va.

The panel selected the finalists based on several criteria, including school counseling innovations, exemplary school counseling programs, leadership and advocacy skills, and contributions to student outcomes.

“ASCA’s School Counselor of the Year program shines an incredibly valuable spotlight on the school counseling profession, bringing attention to exceptional school counselors who are supporting K-12 students every day,” said Jill Cook, CAE, ASCA Executive Director. “School counselors are vital to students’ academic achievement, social/emotional development and plans for life after graduation. The 2022 finalists have demonstrated their commitment to the values and mission of the profession to help all students succeed.”

An in-person celebration is tentatively planned in Washington, D.C., Feb. 3, 2022. The School Counselor of the Year and finalists will be celebrated in a series of virtual events during National School Counseling Week, Feb. 7-11, 2022.
